



# Michigan Nursing Scholarship State of Michigan Department of Treasury

Delta College has received funding from the State of Michigan, Department of Treasury earmarked for nursing scholarships. We would like to encourage you to apply for the following scholarship:

Full-time students with over 12 credits/semester = up to \$2000 per semester  
Three Quarter-time students with 9 credits/semester = up to \$1500 per semester  
Half-time students with 6 credits/semester = up to \$1000 per semester  
Merit scholarship . . . not dependent on financial need

## Student Eligibility Requirements:

- ✚ Must be enrolled at least half-time in a nursing program during the 2008-2009 school year in a Michigan college or university
- ✚ Must be a resident of Michigan for at least 1 year prior to the beginning of nursing program enrollment
- ✚ Must be a United States citizen or permanent resident
- ✚ Must agree to obtain nursing licensure and eligible direct care nursing employment in Michigan within one year of completing academic program
- ✚ Must agree to repay the scholarship if the work requirement or other program provisions are not met
- ✚ Must meet the college's satisfactory academic progress policy
- ✚ No violent felony convictions (requires a confidential criminal background check – forms available in the Nursing Discipline Office)

## Students Who Should Apply:

- ✚ Must be enrolled in and attending a “clinical” nursing course (NUR/NPT 101A & up, NT 163 & up, PNE 121 & up)
- ✚ NPT Students must be enrolled in a minimum of 6 credit hours for scholarship consideration

## Students Applying Must:

- ✚ Complete the attached application
- ✚ Agree that funding is first applied to the cost of tuition, books, and fees associated with the program
- ✚ Have a GPA of 3.0 or better for initial scholarship; and maintain a GPA of 2.75 or better for scholarship renewals
- ✚ Complete a professional essay (less than 600 words) on your Nursing Career Goals
